Upon a motion by Director Muns, second by Director Raddatz, and vote (unanimously in favor), the Fixed Special Assessments were approved.

- 3.2.1 Second Reading and Adoption of Ordinances 24-02 (Annexation 2) and 24-03 (Annexation 3).

 Ordinance 24-02 Upon a motion by Director McKenna, second by Director Nelson, and vote (unanimously in favor), the second reading of Ordinance 24-02 was waived and Ordinance 24-02 was introduced by title only.

Upon a motion by Director Robles, second by Director Raddatz, and vote (unanimously in favor), Ordinance 24-02 was adopted.

Ordinance 24-03 - Upon a motion by Director McKenna, second by Director Raddatz, and vote (unanimously in favor), the second reading of Ordinance 24-03 was waived and Ordinance 24-03 was introduced by title only.

Upon a motion by Director Nelson, second by Director Raddatz, and vote (unanimously in favor), Ordinance 24-03 was adopted.

- **3.2.2** Public Hearing Community Facilities District 2022-1 Annexation 4 The Board of Directors will conduct a public hearing and may move forward with taking actions to approve Community Facilities District 2022-1 Annexation 4.
 - President Robles opened the Public Hearing at 6:40 p.m. With no one requesting to comment, the Public Hearing was closed at 6:40 p.m.
- 3.2.3 Resolution 24-36 The Board of Directors will consider approving Resolution 24-36, Calling a Special Election and Submitting the Qualified Electors of Territory Proposed to be Annexed to the San Miguel Consolidated Fire Protection District, Community Facilities District No. 2022-1, County of San Diego, State of California the Question of Levying Special Taxes Within That Territory (Annexation 4). Upon a motion by Director Pierce, second by Director Woodruff, and vote (unanimously in favor), Resolution 24-36 was adopted.
- 3.2.4 Resolution 24-37 The Board of Directors will consider approving Resolution 24-37, Declaring Results of Special Landowner Election and Directing Recording of Notice of Special Tax Lien for San Miguel Consolidated Fire Protection District Community Facilities District No. 2022-1 Annexation 4. The sealed official ballot was opened and reflected a vote "yes" to annex into CFD 2022-1. Upon a motion by Director Muns, second by Director Raddatz, and vote (unanimously in favor), Resolution 24-37 was adopted.
- 3.2.5 First Reading of Ordinance 24-04 (Annexation 4).
 Upon a motion by Director Nelson, second by Director Woodruff, and vote (unanimously in favor), the first reading of Ordinance 24-04 was waived and Ordinance 24-04 was introduced by title only.
- 3.2.6 Resolution 24-38 The Board of Directors will consider adopting Resolution 24-38 declaring intent to annex property into existing CFD 2022-1 (Annexation 5, Parcel 503-261-07-00).
 Upon a motion by Director Pierce, second by Director Muns, and vote (unanimously in favor), Resolution 24-38 was adopted.

- 3.2.7 Resolution 24-39 The Board of Directors will consider adopting Resolution 24-39 declaring intent to annex property into existing CFD 2022-1 (Annexation 6, Parcel 387-142-36-00).
 Upon a motion by Director Robles, second by Director Pierce, and vote (unanimously in favor), Resolution 24-39 was adopted.
- **3.3** CSDA Board of Directors Election Ballot Term 2025 2027; Seat A Southern Network Upon a motion by Director Robles, second by Director McKenna, and vote (unanimously in favor), staff is directed to cast San Miguel's ballot for incumbent Jo MacKenzie.
- 3.4 Station 18 Demolition Contract The Board of Directors may take action based on a recommendation to award the contract for the demolition of Station 18.
 Upon a motion by Director Pierce, second by Director McKenna, and vote (unanimously in favor), the Board approved awarding the demolition contract, with the contract to list the legal business name of BTS Equipment Unlimited, Inc.

Director Pierce shared that a news conference regarding cancer prevention for firefighters will take place at the Heartland Training Facility on July 30 at 9:30 a.m.

Director Robles received consensus from the Board for the Government Affairs Committee to generate letters to various legislative bodies and engage in conversations with insurance companies about coverage and rates within the District.

Chief Lawler stated that updates on Station 19 (finding property for a permanent station) will be presented regularly. There was discussion around the possibility of a joint-use facility that could be utilized by allied agencies. Director McKenna asked about security and perimeter fencing at Stations 21 and 23 – the need is being addressed with more information to come. Chief Riley shared that additional security measures are being considered for Station 21, and a property survey is being conducted at Station 23 to potentially remove an easement. Chief Lawler discussed the *State of the Insurance Market* document that went out with his Fire Chief Report.

4.4 Association of San Miguel Chief Officers Communications

Battalion Chief Lieberman spoke on behalf of the COA, sharing that the District has five (5) new-hire Firefighter Paramedics coming on board, multiple training and education courses attended by various ranks of personnel, and many strike team deployments in the current fire season. An After Action Review was held at San Miguel following the 2-alarm structure fire on Dictionary Hill, which was attended by our cooperators from SDFD and Heartland Fire. Lastly, the new frontline B6 should be in service within the next month, and the new command vehicle for the Training Division has been secured.

All investments made during the quarter ended June 30, 2024, were in compliance with the County's Investment Policy. The Portfolio structure remains in compliance with the Maturity Policy.

Yield to maturity (YTM) is the estimated rate of return on a bond given its purchase price, assuming all coupon payments are made on a timely basis and reinvested at this same rate of return to the maturity date. Weighted Days to Maturity is average time it takes for securities in a portfolio to mature, weighted in proportion to the dollar amount that is invested in the portfolio. Yields for the portfolio are aggregated based on the book value of each security.

Monthly Investment Returns are reported gross of fees. Administration fees since fiscal year 17-18 have averaged approximately 7 basis points per annum. **All Investments held during the month of June 2024 were in compliance with the Investment Policy dated January 1, 2023. The County Treasurer believes the Treasury Investment Pool contains sufficient cash flow from liquid and maturing securities, bank deposits, and incoming cash to meet the next six months of expected expenditures.

While Safety, Liquidity, and Yield remain the Fund's primary investment objectives, all else being equal and acting under statutory investment limitations, the County Treasurer affirms his/her commitment to the consideration of ESG criteria in evaluating securities. Sustainalytics, a Morningstar Company, provides high-quality, analytical environmental, social and governance (ESG) research, ratings and data to institutional investors and companies. Using Sustainalytics scoring, which is available on Bloomberg, the Pool had a weighted average MTN/CP/CD score of 19.98 as of 06/30/24, placing it in the "Medium Risk" category. Sustainalytics' ratings categories are: negligible (0-9.99), low (10-19.99), medium (20-29.99), high (30-39.99) and severe (40+).

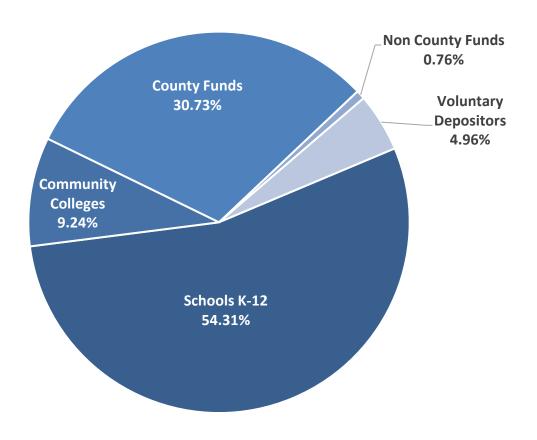

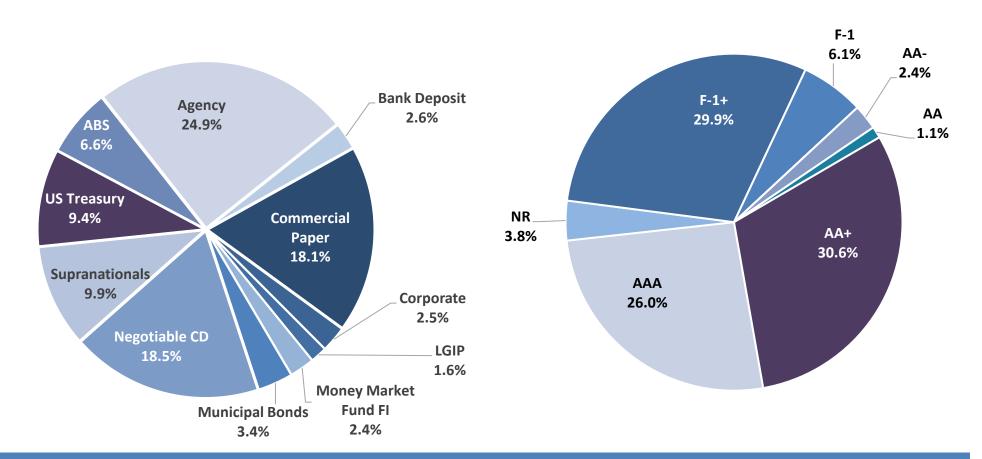

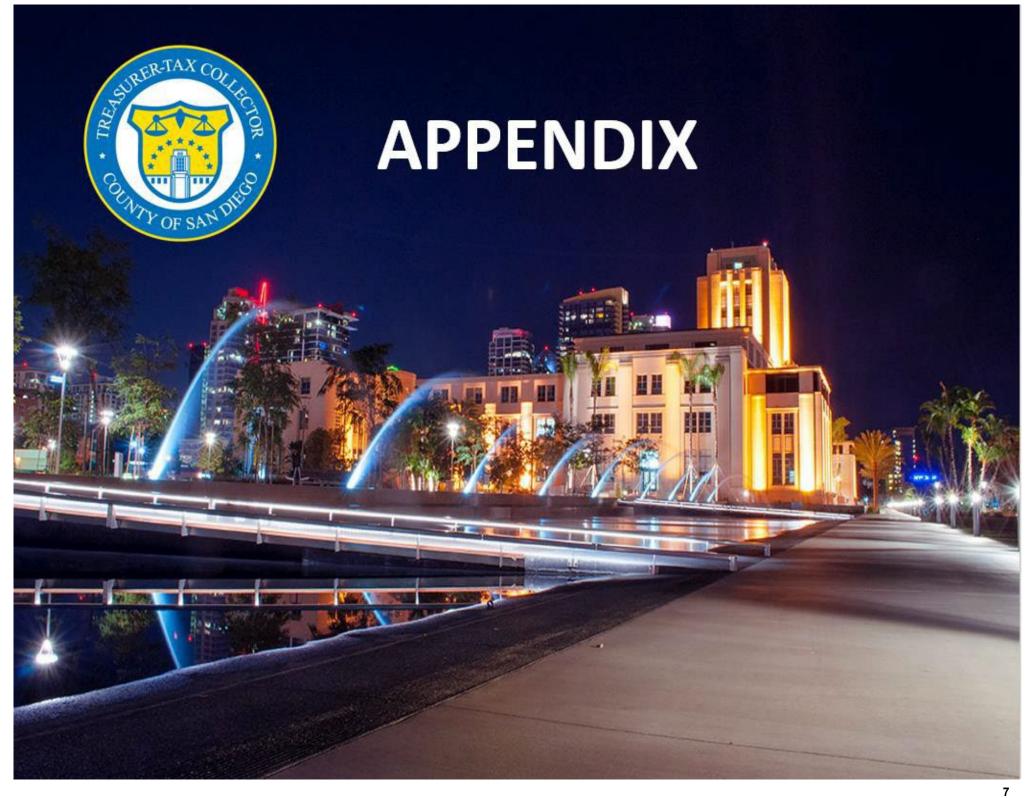

SUBJECT: CFD 2022-1, Finalize Annexation4 via Ordinance 24-04

BACKGROUND

On September 14, 2022, the District received their first petition for a CFD and on October 12, 2022, approved Ordinance 2022-2 Levying Special Taxes Within San Miguel Consolidated Fire Protection District. Annexation 1 was approved May 10, 2023. Since then, qualifying projects have annexed into CFD 2022-1.

DISCUSSION

Resolution 24-24 declared intent to annex property into CFD 2022-1 via Annexation 4, and was adopted at the regular meeting of the Board of Directors on June 12, 2024. A public hearing and election occurred at the July 24, 2024 regular meeting (Resolutions 24-36 and 24-37), with a first reading of the Ordinance occurring at that same meeting. Tonight's meeting of August 14, 2024 presents Ordinance 24-04, which finalizes Annexation 4 with its adoption.

FISCAL IMPACT

None, as the costs for the formation of CFD 2022-1 are paid through a deposit provided by the Developer and ongoing administrative costs are paid for through the levy of special taxes within CFD 2022-1.

Ordinance 24-04

Ordinance of the Board of Directors of the San Miguel Consolidated Fire Protection District Authorizing the Levy of Special Taxes in a Community Facilities District, Including Certain Annexation Territory Identified as Annexation 4, into San Miguel Consolidated Fire Protection District Community Facilities District 2022-1

WHEREAS, the Board of Directors (the "Board") of the San Miguel Consolidated Fire Protection District (the "District") has established the San Miguel Consolidated Fire Protection District, Community Facilities District No. 2022-1, County of San Diego, State of California ("CFD No. 2022-1") for the purpose of levying special taxes on parcels of taxable property therein for the purpose of providing certain services, which are necessary to meet increased demands placed upon the District as a result of the development of said real property; and

WHEREAS, the rate and method of apportionment of special tax for CFD No. 2022-1 is set forth in Exhibit "C" to the Board Resolution 24-24, which was adopted on June 12, 2024 (the "Resolution of Intention"); and

WHEREAS, the District has conducted proceedings to annex territory into CFD No. 2022-1 and, with respect to the proceedings, following an election of the qualified electors in the territory proposed for annexation (the "Annexation No. 4"), the Board, on July 24, 2024, adopted a resolution which declared the results of the special election and determined that the territory proposed to be annexed is added to and part of CFD No. 2022-1.

NOW, THEREFORE, BE IT RESOLVED that the Board of the San Miguel Consolidated Fire Protection District, California, acting in its capacity as the legislative body of the San Miguel Consolidated Fire Protection District, Community Facilities District No. 2022-1, County of San Diego, State of California, does hereby:

Section 1.

The foregoing recitals are true and correct.

Section 2.

By the passage of this Ordinance, the Board hereby authorizes and levies the special tax within CFD No. 2022-1, including the Annexation Territory, pursuant to Article 3.5 (commencing with Section 53339) of Chapter 2.5 of Part 1 of Division 2 of Title 5 of the California Government Code, commonly known as the "Mello-Roos Community Facilities Act of 1982," (the "Act"), at the rate and in accordance with the rate and method of apportionment of special tax set forth in the Resolution of Intention, which rate and method is by this reference incorporated herein. The special tax has previously been levied in the original

territory of CFD No. 2022-1 pursuant to Ordinance No. 2022-2 passed and adopted by the Board on October 12, 2022, and the special tax is hereby levied commencing in Fiscal Year 2023-24 in CFD No. 2022-1, including Annexation 4, and in each fiscal year thereafter to pay for the services for CFD No. 2022-1 and the costs of administering the District.

Section 3.

The Fire Chief or designee or employee or consultant of the District is hereby authorized and directed each fiscal year to determine the specific special tax to be levied for the next ensuing fiscal year for each parcel of real property within CFD No. 2022-1, including Annexation 4, in the manner and as provided in the Resolution of Intention.

Section 4.

Exemptions from the levy of the special tax shall be as provided in the Resolution of Intention and the applicable provisions of the Act. In no event shall the special tax be levied on any parcel within CFD No. 2022-1 in excess of the maximum special tax specified in the Resolution of Intention.

Section 5.

All of the collections of the special tax shall be used as provided in the Act and in the Resolution of Intention, including, but not limited to, the payment of the costs of the services, the payment of the costs of the District in administering CFD No. 2022-1, and the costs of collecting and administering the special tax.

Section 6.

The special tax shall be collected in the same manner and at the same time as ordinary *ad valorem* taxes are collected and shall have the same lien priority, and be subject to the same penalties and the same procedure and sale in cases of delinquency as provided for *ad valorem* taxes; provided, however, that CFD No. 2022-1 may collect Special Taxes at a different time or in a different manner if necessary to meet its financial obligations. The General Manager of the District, or his or her designee, is hereby authorized and directed to provide all necessary information to the auditor/tax collector of the County of San Diego in order to effect proper billing and collection of the special tax, so that the special tax shall be included on the secured property tax roll of the County of San Diego for Fiscal Year 2023-24 and for each fiscal year thereafter until no longer required to pay for the Services or until otherwise terminated by the District.

Section 7.

If for any reason any portion of this Ordinance is found to be invalid, or if the special tax is found inapplicable to any particular parcel within CFD No. 2022-1, including Annexation 4, by a court of competent jurisdiction, the balance of this Ordinance

and the application of the special tax to the remaining parcels within CFD No. 2022-1, including Annexation 4, shall not be affected.

Section 8.

This Ordinance shall be effective thirty (30) days after its adoption. Within fifteen (15) days after its adoption, the Board Clerk shall cause this Ordinance, or a summary of it, to be published in a newspaper of general circulation in the District.

STAFF INVOLVEMENT
